ORDER TO SHOW CAUSE AND INJUNCTION

Whereas a Petition for Appointment of Commissioner as Receiver pursuant to NRS 696B.250 ("Petition") was filed in the above entitled Court initiating these proceedings, and;

GOOD CAUSE APPEARING, Defendants are HEREBY ORDERED to appear and show cause why the Petition for Appointment of Commissioner as Receiver pursuant to NRS

696B.290 should not be permanently granted against Insurers on the 26th day of June,

at the hour of 8:30 (a.m./p.m.), Department 4 of the Eighth Judicial District

Court in Las Vegas, Nevada.

1 IT IS FURTHER ORDERED that in the interim, before the above show cause hearing,
2 The Commissioner of Insurance for the State of Nevada, Scott J. Kipper, is appointed as a
3 Temporary Receiver of PROFESSIONAL AVIATION INSURANCE RECIPROCAL, a Nevada
4 Domiciled Reciprocal Captive Insurance Company, (hereinafter "Insurer").

5 IT IS FURTHER ORDERED that pursuant to NRS 696B.270, pending the show cause
6 hearing and further orders by the Court, Insurers, all officers, directors, stockholders,
7 members, subscribers, agents, employees, and all other persons, except the Receiver or any
8 person or persons designated by the Receiver, are immediately enjoined from transacting any
9 further business on behalf of the Insurers or wasting or disposing of any assets or property of
10 Insurer.

11 IT IS HEREBY FURTHER ORDERED that pursuant to NRS 696B.270 and 696B.340,
12 pending the show cause hearing and further orders by the Court, all persons are hereby
13 immediately restrained from the commencement or prosecution of any actions by or on
14 behalf of the Insurer or against the Insurer. Further, all persons are hereby restrained from
15 obtaining any preferences, judgments, attachments, or other liens as to any property of the
16 Insurer, or making any levy against the Insurer or against its assets or any part thereof.

17 IT IS HEREBY FURTHER ORDERED that pursuant to NRS 696B.270, pending the
18 show cause hearing and further orders by the Court all persons other than Receiver are

2 property from Insurers.


