ORDER GRANTING MOTION REQUESTING THE SETTING OF A CLAIMS FILING DEADLINE AND GRANTING RELATED RELIEF

Currently before the Court is Barbara D. Richardson's (the "Commissioner"), Commissioner of Insurance in her capacity as Permanent Receiver of Physicians Indemnity Risk Retention Group, Inc., *Motion Requesting the Setting of a Claims Filing Deadline and Granting Related Relief* ("Motion") filed and submitted to the Court for consideration on April 22, 2022. On April 29, 2022, this Court issued an *Order Vacating Submission* to allow the appropriate time for a response. The Commissioner resubmitted the Motion on May 16, 2022.

¹ No Opposition was filed in this matter. *See* D.C.R. 13(3) ("Failure of the opposing party to serve and file a written opposition may be construed as an admission that the motion is meritorious and a consent to granting the same.").

Based upon the foregoing for good cause appearing,

IT IS HEREBY ORDERED that:

- 1. The proposed Proof of Claim ("POC") procedure described in the Motion, including the forms and instructions attached as Exhibits 1-3 to the Motion, are approved;
- 2. The proposed Receivership Appeal Procedure described in the Motion, including the forms and instructions attached as Exhibits 3 & 4 to the Motion, are approved.
- 3. Claim and appeal processing procedures substantially in the form as those described within and presented as Exhibits to the Motion comply with applicable Nevada law, and are within the authority granted to the Receiver by the Permanent Receivership Order and applicable Nevada law;
- 4. The proposed notice procedures described in the Motion are approved, and the Court finds that notice procedures in the same or substantially similar form comply with the requirements of Nevada law and due process (including the forms of notice attached as Exhibit 1 and Exhibit 5 to the Motion);
- 5. **December 1, 2022**, is established as the deadline (the "Claims Filing Deadline") for filing and rendering absolute, non-contingent, and liquidated in amount, claims against PIRRG;
- 6. This Claiming Filing Deadline applies equally to any tail coverage claims unless the actual end of tail coverage under the individual policy occurs first;
- 7. All claims against PIRRG not postmarked on or before the Claims Filing Deadline and received at the address specified by the Receiver will be deemed not timely filed and shall be barred, not subject to processing by the Receiver, and ineligible to share in any distribution of the assets of the estate PIRRG shall have no liabilities as to any such late-filed claims;
- 8. Claims which have not been rendered absolute (*i.e.*, both liquidated in amount and non-contingent) on or before the Claims Filing Deadline may not share in the assets of the receivership estate (subject to any applicable exceptions found in NRS 696B.450, which will be in the Receiver's sole discretion to determine);
