**ORDER APPROVING ASSET DISTRIBUTION**

**THIS MATTER** has come before the Court upon the State of Wyoming's Motion for Order Approving Asset Distribution. The Court held a hearing on the motion on March 1st, 2021. The Court, having read the motion and being fully advised in this matter, finds that legal grounds exist under Wyo. Stat. Ann. § 26-28-125(a)(iii) to approve the distribution.

**IT IS ORDERED**, that


1. The Wyoming Insurance Commissioner has the authority to disburse funds to the claimants identified in his motion under Wyoming Statute § 26-28-125(a)(iii).

2. The Commissioner's proposed distribution reserves sufficient assets to administer the estate until all acts necessary to complete all closing tasks are complete.

3. The Commissioner is authorized to distribute funds as identified in his Motion for Order Approving Asset Distribution.

4. When all remaining acts to close the WINHealth estate are complete, any remaining funds shall be distributed to Class (a)(iii) claimants on the same basis as articulated in the Commissioner's Motion for Order Approving Asset Distribution, and the WINHealth estate shall be closed.
