19 **ORDER FOR HEARING TO CONSIDER MOTION TO MODIFY CLAIMS PROCESS PER**
20 **RECOMMENDATION OF RECEIVER PURSUANT TO NRS 696B.330(4)**

21 This Court reviewed Plaintiff's Motion To Modify Claims Process Per Recommendation
22 of Receiver Pursuant to NRS 696B.330(4), submitted October 22, 2014. The Court now finds
23 and orders as follows:

24 1. Plaintiff states the available assets of NGIC are not sufficient to pay claims beyond
25 the administrative class, and therefore, the obligation of the Receiver to execute
26 and administer a proof of claim process for claimants and vendors (who will never
27 receive a distribution) is costly and will not benefit the receivership estate.

1 2. The Court approves the plan to notice all prior policyholders, claimants, creditors,
2 and interested parties of the NGIC liquidation and of the hearing on the modification
3 of the claims process. The Receiver will notify all of the above mentioned persons
4 by mail and by publication in the two newspapers of largest circulation in the state of
5 Nevada as well as on the NGIC web site and RSG (Receivership Manager) web
6 site.

7 3. A hearing is ordered to consider the Motion to Modify Claims Process Per
8 Recommendation of Receiver Pursuant to NRS 696B.330(4), and is scheduled for
9 January 26, 2015, at 9:30 AM. Opposition to this Motion to Modify Claims
10 Process Per Recommendation of Receiver must be received and properly
11 submitted pursuant to the Rules of Practice for the Second Judicial District Court of
12 the State of Nevada, to this Court, by December 31, 2014.
