### OFFICIAL LEGAL NOTICE:

#### NOTICE TO ALL POLICYHOLDERS, INSUREDS, CREDITORS, SHAREHOLDERS, REINSURERS, AND ALL OTHER PERSONS OR ENTITIES INTERESTED IN THE ASSETS OF PROFESSIONAL AVIATION INSURANCE RECIPROCAL

NOTICE IS HEREBY GIVEN that on July 3, 2014 the Eighth Judicial District Court for the State of Nevada, Clark County entered an Order Appointing Nevada Insurance Commissioner Scott J. Kipper as the permanent receiver for PROFESSIONAL AVIATION INSURANCE RECIPROCAL (Case No. A-14-700829-P). The Commissioner retained Regulatory Services Group as the Receivership Manager. The Court directed the Receiver to marshal assets and wind up the business and affairs of PROFESSIONAL AVIATION INSURANCE RECIPROCAL. PROFESSIONAL AVIATION INSURANCE RECIPROCAL's Board of Directors then voluntarily agreed to the liquidation of the company.

NOTICE IS FURTHER GIVEN that any and all policyholders, insureds, creditors, shareholders, reinsurers, or other persons having any claim or demand of any kind against PROFESSIONAL AVIATION INSURANCE RECIPROCAL must file their claim together with proper proof thereof with the Receiver, c/o The Regulatory Services Group, P.O. Box 26894, San Francisco, CA 94126, **on or before July 31, 2015 (the "Claims Bar Date")**. Any claims not filed on or before the Claims Bar Date shall be deemed waived. Failure to file a proof of claim by the Claims Bar Date will forever bar you from making a claim against PROFESSIONAL AVIATION INSURANCE RECIPROCAL.

As defined by NRS 696B.330 a claim must be filed in the manner and form established by the Receiver and set forth in reasonable detail the amount of the claim, or the basis by which the amount can be ascertained, the facts upon which the claim is based, and the priorities asserted, if any. All such claims must be verified by the affidavit of the claimant, or someone authorized to act on behalf of the claimant and having knowledge of the facts, and be supported by such documents as may be material thereto.
